



Moving Forward


- ▶ Need a vision for what police planning & research should be – a vision that is widely shared among police CEOs.

- ▶ Need a network of police planners & researchers to support each other (IALEP, LEOPRD, IACA, etc.).


- ▶ Need a system to prepare people to perform police planning & research duties:


Getting Started





- ▶ the use of the phrase “planning and research” is a misnomer. Few police departments engage in anything but cursory research programs.




Today – Program de Jour


Resident Smart Guys


Production Shop

A Basic Framework

- ▶ CEOs, commanders, managers, officers → they all make decisions
 - ▶ Planning – what you do to prepare in advance in order to make (and then implement) good decisions → forecast conditions, clarify objectives, identify and assess alternatives, etc.
 - ▶ Research – systematic collection (and/or production) of valid information about conditions, objectives, alternatives, etc.

Strategic Planning

 - Homeland security
 - Intelligence analysis
 - Information sharing
 - Emergency management
 - Continuity of government

Problem-Specific Planning

- ▶ What is the role of planning & research in helping the agency address specific new problems in the community?
 - Copper theft
 - Identity theft
 - Meth labs
 - Emotionally disturbed persons
 - No snitching
 - Etc.

Technology Planning


- ▶ What is the role of planning & research in helping the agency select, design, and implement new technologies, such as:
 - Mobile data systems
 - Tasers
 - Unmanned aircraft
 - Surveillance cameras
 - Automated traffic enforcement
 - Etc.

Human Resource Planning


- ▶ What is the role of planning & research in helping the agency recruit, select, train, retain, and promote the best possible people, such as:
 - Planning, designing, and evaluating recruiting campaigns
 - Validating selection systems
 - Training design, including evaluation and validation
 - Validating EWS/EIS systems
 - Etc.




- ▶ Need a vision for what police planning & research should be.


- ▶ Need a system to prepare people to perform police planning & research duties:

Time to Get Serious

- ▶ There is no current textbook on police planning & research.
 - ▶ There is no college degree in police planning & research.
 - ▶ There is little training available on police planning & research.
 - ▶ In fact, the more general topic of “police administration” has gotten little serious attention the last 30 years.
- 

- ▶ On the bright side, lots of good pieces are available:
 - Research on police strategies & programs (what works)
 - Research on police problems (crime, disorder, etc.)
 - Methods & techniques from other fields – public administration, urban planning, emergency planning, etc.
 - ▶ These chunks of knowledge and methods could be “packaged” fairly easily
- 

- ▶ But ... they should be set within a framework of police administration and police planning – they should be contextualized to make them as relevant and practical as possible
 - ▶ This won't be easy to do within the parameters of current higher education turf – i.e., within criminal justice or public administration programs
- 

- ▶ We have a lot of think tanks and universities, but we lack a mechanism to pull it together and transmit it throughout the police system and to the next generation
 - ▶ Does anybody have the courage and opportunity to create something brand new that is tailored to the needs of modern police planning & administration?
 - FBI?
 - FLETC?
 - PERF?
 - Some university or consortium of universities?
- 

- ▶ The greatest strength of our police system is its decentralization, fragmentation, diversity
 - ▶ But that's our greatest weakness too, or at least challenge to be overcome
 - ▶ We could really use a National Police College
